**Subject: Chapter 147 – Vehicles, Removal  
And Storage Of**

**Purpose**

**An ordinance concerning Vehicles, Removal and Storage Of.**

**For the purpose of amending the Code of the Town of Leonardtown in order to revise existing provisions.**

**Ordinance**

**Section I: Be it ordained by the Council of the Town of Leonardtown that Chapter 147. Vehicles, Removal and Storage Of, is hereby amended as follows: (changes shown in red)**

**CHAPTER 147. VEHICLES, REMOVAL AND STORAGE OF**

**[HISTORY: Adopted by the Mayor and Council of the Town of Leonardtown 10-9-1990 by Ord. No. 66. Amendments noted where applicable.]**

**GENERAL REFERENCES**

Vehicles and traffic — See Ch. [146](#).

**§ 147-1. Authority.**

The Town of Leonardtown, by and through the Town Administrator, may authorize the removal and storage of any illegally parked or abandoned motor vehicle(s) **located within the Town.**

**§ 147-2. Notice of intent to remove.**

Prior to said removal, the Town Administrator shall have placed upon said offending motor vehicle(s) notice of intent to remove at least 72 hours prior to said removal.

**§ 147-3. Reimbursement for costs.**


The owner(s) of said offending motor vehicle(s) shall reimburse the Town of Leonardtown for all reasonable costs associated with removing said motor vehicle(s) before release of the vehicle to said owners(s).

**Section II: And Be It Further Ordained,** that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the affirmative vote of four-fifths of the whole Council after veto by the Mayor.






