

Resolution 4-23
Resolution Ratifying, Confirming and Approving the
Appointment of the Current Treasurer and the
Current Town Attorney

RESOLUTION

A RESOLUTION of the Council of The Commissioners of Leonardtown (the "Town") ratifying, confirming and approving the prior appointment of the current Treasurer and the current Town Attorney; and generally relating to such appointments.

RECITALS

WHEREAS, Section 701 of the Charter (the "Charter") of The Commissioners of Leonardtown (the "Town") provides that the Mayor of the Town (the "Mayor") with the approval of the Council of the Town (the "Council") shall appoint a Treasurer of the Town (the "Treasurer"); and

WHEREAS, Marie Angie Graves has been serving as the Treasurer since March 21, 2022, but the records of the Town do not reflect her appointment in accordance with the Charter; and

WHEREAS, Section 802 of the Charter provides that the Mayor with the approval of the Council may appoint a town attorney (the "Town Attorney"); and

WHEREAS, since at least February 2017 Patrick W. Thomas of MacLeod Law Group, LLC has been serving as the Town Attorney, but the records of the Town do not reflect his appointment in accordance with the Charter; and

WHEREAS, from time-to-time, other attorneys of MacLeod Law Group, LLC provide legal services to the Town; and

WHEREAS, because the records of the Town do not reflect the approval by the Council as required by the Charter of the appointment of the current Treasurer and the current Town Attorney, bond counsel to the Town has requested that the current Council ratify, confirm and approve such officials' prior appointments.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Town of Leonardtown as follows:

SECTION 1. The Recitals to this Resolution are incorporated by reference herein and are deemed a substantive part of this Resolution, and capitalized terms defined in the Recitals to this Resolution and used in the Sections of this Resolution will have the meanings given to such terms in the Recitals hereto.

SECTION 2. The appointment of Marie Angie Graves as Treasurer effective as of March 21, 2022 is hereby ratified, confirmed and approved. Furthermore, it is recognized that Ms. Graves typically signs official documents using the name Angie Graves.

SECTION 3. The appointment of Patrick W. Thomas as Town Attorney effective as of February 2017 is hereby ratified, confirmed and approved. Furthermore, it is recognized that other attorneys of MacLeod Law Group, LLC are authorized to provide legal services to the Town in support of Mr. Thomas or in the capacity of Town Attorney in Mr. Thomas's absence or unavailability or with the consent of the Mayor or the Town Administrator of the Town.

SECTION 4. This Resolution shall take effect from the date of its adoption.


