

RESOLUTION NO. 4-77

A RESOLUTION PROVIDING AND ESTABLISHING RATES FOR WATER SERVICE
AND SEWERAGE DISPOSAL SERVICE IN LEONARDTOWN

WHEREAS, The Board of Leonardtown Commissioners after due and careful consideration have concluded that the following rate schedule for water service and sewerage disposal service is fair, just, equitable and fiscally responsible.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED BY THE COMMISSIONERS OF LEONARDTOWN, MARYLAND as follows:

I. Quarterly rates by Residential users for water within the Town limits will be a flat charge of \$10.80.

II. Quarterly rates by Residential users for sewerage disposal within the Town limits will be a flat charge of \$17.82.

III. Quarterly rates by Residential users for water outside the Town limits will be double the charge of within Town users.

IV. Quarterly rates by Residential users for sewerage disposal outside the Town limits will be double the charge of within Town users.

V. Quarterly Metered rates by Commercial users for water within the Town limits will be:

(a) \$.54 per 1,000 gallons up to 20,000 gallons with a minimum quarterly rate of \$10.80.

(b) \$.40 per 1,000 gallons for usage between 20,001 and 50,000 gallons.

(c) \$.30 per 1,000 gallons for usage over 50,000 gallons.

VI. Quarterly Metered rates by Commercial users of sewerage disposal within the Town limits will be:

165% of metered water rate as determined quarterly.

VII. Metered rates of users of Town water of Commercial properties outside the Town limits will be:

Doubled the rate of users in Town as set forth in Paragraph V

VIII. Any other usage of water in bulk not specified otherwise herein may be charged the same rate as Paragraph VII.

Volunteer fire departments are exempt from this Resolution.

DELINQUENT NOTICES:

A delinquent notice will be sent after two quarters of non payment. The Town reserves the right to discontinue Utility Service for failure to pay fifteen(15) days after delinquency notice is mailed. Reconnection fee shall be \$25.00.

DELINQUENT CHARGE:

Minimum monthly delinquency charge of 1 1/2% beginning with the second month following the quarter for which payment is due.

Minimum of 18% per annum on delinquent accounts.

This Resolution shall be effective the 1st day of July, 1977.
